



Finally I would like to thank all of you, EC members, Youth and Women Group, Doctors and Donors for the help they have given.

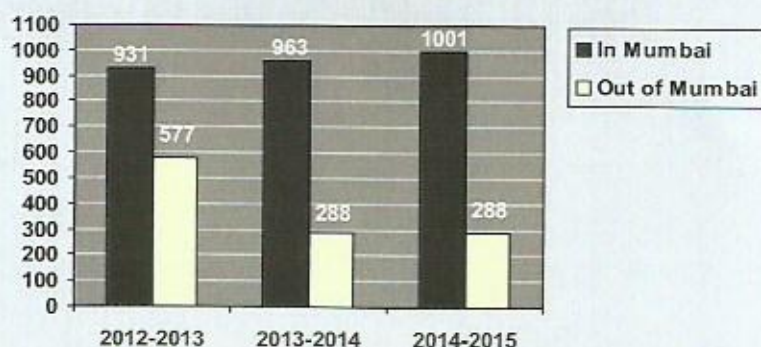

Did you know?

"Hemophilia, in one third of the cases, arises from spontaneous mutations. It means, any of the so called healthy couples could get a Hemophiliac son at any point of time."

Total 30 Major Operation done on Person with Hemophilia.

Total 41 Carrier Detections done in Hemophilia A and B families by DNA analysis:

In the current year, 34 Hemophilia A and 6 Hemophilia B and 1 FXIII families were referred for the detection of carrier status in 55 women. 25 women were detected to be carriers while 30 were non-carriers.

Total 75 Prenatal Diagnosis done by chorionic villus sampling procedure:

56 females belonging to Hemophilia A, 14 females belonging to Hemophilia B families were referred in first trimester for prenatal diagnosis. In case of Hemophilia A and B families, 19 fetuses were found to be affected.

Apart from the above tests, we have also routinely done HIV / HCV tests at KEM Hospital.

Special Cell for HIV / HCV PWH:

Our special cell for HIV and HCV PWH is being managed by our committed committee member Mr. Girishbhai Joshi. We have issued 2,270 i.u. of free Factors to our 6 HIV positive patients during the year.

Mr. Joshi regularly attends to the needs and grievances of PwH, besides extending psychosocial support to them. He is also giving free food and medicines to the patients admitted in Ward 42 of KEM Hospital as well as to other poor and needy patients.

Mr. Joshi has collected donation of Rs. 1,67,133/- from well wishers and friends for the above activities. We sincerely appreciate this gesture of Mr. Joshi. Thanks to Mr. Mehul Patel, Krunal Bhatt, Vijay Bhai and his friends donating us Texakind, Etorioxib, Hemostate and Calcirol Costing Rs. 40,600.00



Remarkable Medical Help:

Mr. Roomy Daruwalla by profession is a businessman who came to know about Hemophilia and sufferings of PwH. In this year, we have received Rs. 75,200/- as a donation from Mr. Roomy. We are providing free medicine from this fund to our PwH. We are thankful to him for the kind of support he is providing for our Hemophiliacs.

Homeopathy Workshop at HSMC:

HSMC has started Homeopathy Workshop every 3rd Sunday of each month. In every workshop around 30-35 PwH visit Dr. Hiral Bothra, she gives guidance and Homeopathic Medicines to our PwH. This alternative treatment is being very helpful to our PwH. We recommend all the PwH to avail the benefit of this workshop.

AGM of HSMC Last Year:

215 members were attended 22nd AGM which took place on 17th August 2014 at KEM Hospital. Regular affairs of the AGM was discussed.

HFI AGM at Kolkata on 13th / 14th Sept'2014:

E.C Members Mrs. Indira Nair, Mr. Paresh Parmar, Mr. Ajay Palande, Zulfiqar Colombowala attended Hemophilia Federation of India AGM held on 13th & 14th Sep. 2014.

Awareness Program in Udaipur:

Our EC Member Mr. Kamlesh Gupta & Mrs. Asha Gupta went to Udaipur in the month of September 2014 to attend National AGM of Indian Scout Guide Fellowship. In this program Mrs. Asha briefed introduction on Hemophilia and its complications and also they distributed pamphlets.

CME for Doctors of ESIC:

Hemophilia Society along with Novo Nordisk arranged CME for ESIC Doctors on 17th May 2015 at Andheri Sai Palace Hotel to enhance their knowledge about treatment on Hemophilia.



Awareness during Yogayana Festival at Bhavan's College:

Yogayana Festival, on 16th to 18th January 2015, HSMC has successfully participated in this program. This was organized by "Bhavans Yoga Bharati" at Bhavan's College Campus, Andheri, Mumbai. In this three days various program was on Yoga and various NGO's members holding their stalls for awareness. There were more than 1000 visitors in this program which included students, parents and



other people from all walks of life.

Mrs. Indira Nair and Mrs. Jumana Colombowala along with other Women Groups Members & Youth Groups members took part in this program and spread awareness. We had also kept few hand-made decorative stuff made by the mother of a PwH to sell during the program.

College of Social Work - Nirmala Niketan:



Nirmala Niketan Extension Centre, Goregaon on 10th December 2014 and further on 27th March 2015 for the Senior Citizens doing their short term course in social work.

The college invited us to speak on Hemophilia. Mrs. Indira Nair explained in detail about Hemophilia and the activities of HSMC. After her detailed presentation, various queries were replied to their satisfaction. Mr. Chetan introduced by giving some brief on Hemophilia. Mr. Balshiram spoke about Hemophilia and shared his personal experience. He had also explained about NRHM and lobbying with Maharashtra government and shared objective of Hemophilia Society Mumbai.

HIV & HCV cell. Mr Chetan spoke about the importance of youth group, why it is required in every chapter and made a presentation.

All the participants watched our short film "Wings to Fly". All of them appreciated the film and its message. Mr. Sunil explained them in detail about our Youth group activities and specially emphasized on HCV and its complications and the treatment.

Helping HCV Positive PwH:

Rupal panchal along with Dr Akasha shukla with support from ROCHE had conducted routine HCV antibody testing and HCV RNA for PwH who tested positive. We have conducted a Awareness talk in Thane Civil on Hemophilia Day and on Dr Alison Visit. Further this year we have treated 3 HCV cases and most of them have responded well with Ajay Palande achieving SVR negative. This year we have started treating patient with "Sovaldi" and for one of the cases we have procured it at 50% of MRP. Rupal Panchal in August 2015 has represented Hemophilia in Lawyers Collective for HCV Advocacy. We also organised a HCV Awareness talk by Dr Akasha Shukla in HFI annual meeting held recently. Currently they are trying to arrange for New DDA 5 drugs at low or free cost on compassionate ground for HCV patient who cant use current line of treatment.

Courtyard Marriott get-together with PwH:

The representatives from Courtyard Marriott, visited HSMC Office to meet the PwH (Person with Hemophilia) children. Our 10 CWH between age group 5-10 years old were present on this occasion. They brought a beautiful cake for children and packed gift. The children enjoyed with the delicious cake and pastries.

Hemophilia Day Celebration



Hemophilia Society Mumbai (Chapter) celebrated the World Hemophilia Day on 19th May 2015 at K.E.M. Hospital. Total of 145 PWH and their family members attended the program.

H.C.V. test for the PWH and family members were done with the help of Roche Company. 40 to 45 PWH has undergone the screening.

President informed that the World Hemophilia Day is celebrated in the memory of Mr. Frank Schnabel on his birthday. This year's theme was 'Binding a Family of Support'. It means we all should support each other in every situation whether it is good or bad. PWH who passed SSC, HSC, or completed the graduation, post graduation were felicitated by chief guest Mr. Romy Daruwala.

Mrs. Indira Nair informed that under 'micro enterprises project' by LA Kelly communication has sanctioned USD \$1000 (Rs. 66,000 approx) to Mr. Tarun Ledhvani for starting business.

A short film 'Ummide', Directed by Mr. Rohit Gadhave, was launched on this occasion. Dr. Chandrakala from Department of Hematology, K.E.M. Hospital advised PWH about importance of adequate and timely treatment. She also answered all the questions put to her by PWH and their relatives regarding Inhibitors, antenatal checking, carrier detection. Apart from this, various medical fraternity from KEM hospital visited and advised on hemophilia day to day care.

Entertainment program was presented by PwH and the guests. Some songs on guitar were played by youth group members.



Awareness in Radio Channel:

Youth group successfully created awareness in All India Radio station on 13th April 2015 on account of World Hemophilia day. Dr. Ghosh & Mrs. Indira Nair gave information about Hemophilia and its treatment to audience of All India Radio & its other radio channels.

Fund received USD \$ 14,700 (Rs. 9.5 Lac approx) from Save One Life, USA was distributed in all 4 quarters to 62 beneficiaries. SOL beneficiary were called two time for the meeting, held on KEM conference room on February 2015 and July 2015.



Hans Foundation fund for Education:

Rs. 1,09,200 sponsorship fund received in three quarters from HFI for education of 14 CwH. This is only one year's project.

Educational Help:

HSMC distributed Rs. 82,000/- to the 27 CwH for education in year 2014-15

Project under Foreign Donation (FCRA):

Nurses Project:

This project is awarded by Valentine Trust, UK with the help of Dr. Alison (UK national). This project going on under the guidance from Occupational therapist Dr. Jayshree Kale and Dr. Kirti Patil of KEM Hospital. During the last year we have taken services of Eleven Occupational Therapist. They have visited 173 times from Aug. 2014 to July 2015 to needy PwH's at home and given treatment and Ultra Sound treatment. All the PwH are provide this service free of charge and they are satisfied with the services of this dedicated Occupational therapists. The society invites needy PwH to contact office so more PwH would be covered under this project.

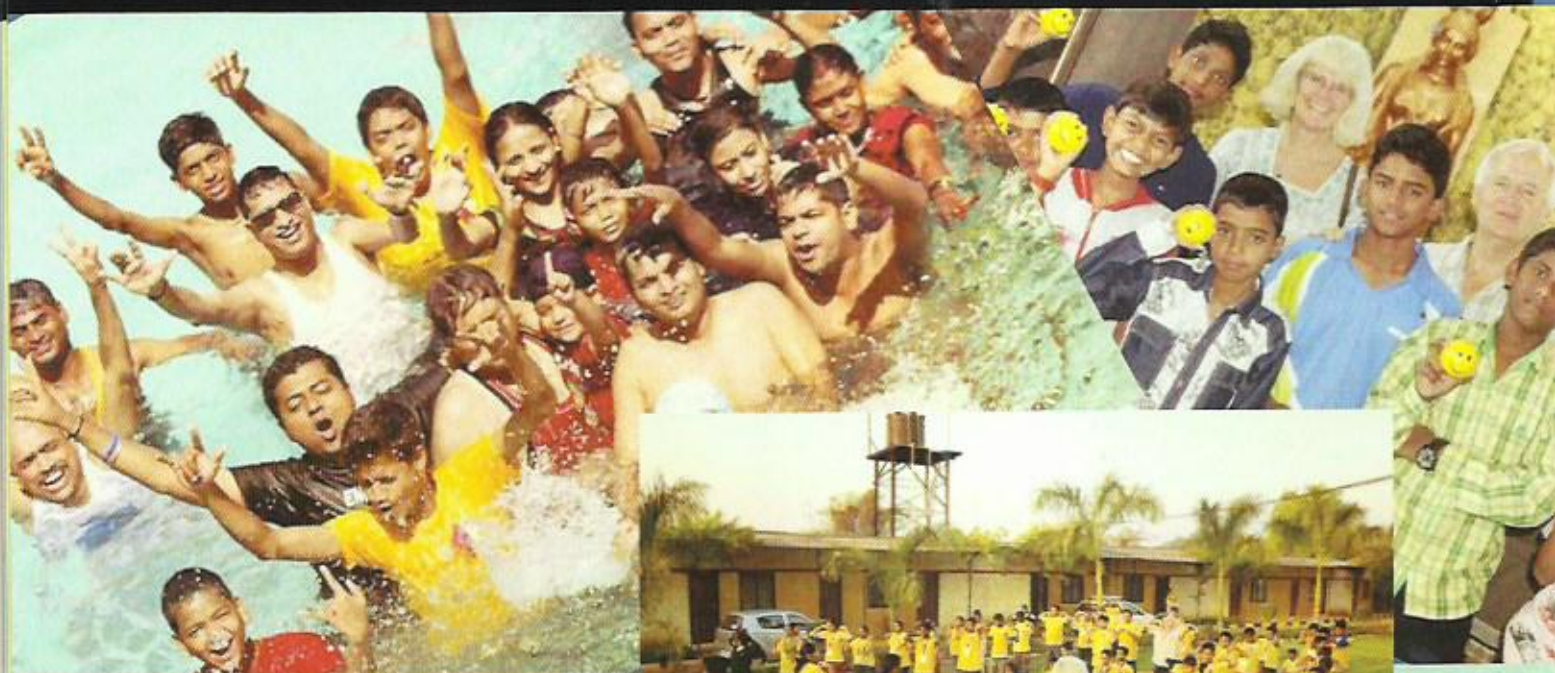
HCV Viral Load Test:
