Message By Dr. Chandrakala



We in the department of hematology are treating PWH for more than 25 years. Till last 6 to 7 years, cryoprecipitate and FFP was the main line of therapy for PWH in India. With the help of DHS and BMC, all our patients are receiving CFCs. All of them were on episodic therapy. Since last 2 years, few of our children are started on prophylaxis therapy. This has reduced direct and indirect costs of patients as well as their families. Now more and more patients are aware of prophylaxis treatment and benefits of it. In the city of Mumbai to travel to hospital for prophylaxis is a major task and they had to spend lot of time to come to hospital for prophylactic therapy. Our aim was to make them independent as well as train parents for infusion in their children for home therapy.

We conducted 8 sessions of training over a period of 3 months, starting 1 month after start of prophylaxis. After 3 months of training, all of the parents were trained in infusion of their children and after 8 monitored sessions were shifted to home care. Currently, there are 65 patients between 1 -10 years of age on prophylaxis and out of these 18 patients on home therapy.

With availability of long acting factor from WFH, we extended the prophylaxis programme even further till 15 years of age. Patients were 100% compliance and improved quality of life, reduced joint bleeds and life threatening bleeds, reduced school / college absenteeism. 4 patients are currently on ITI therapy.

In KEM hospital, we have 911 PWH registered till date and 280 patients registered in last 1 year. With availability of prophylaxis and dramatic improvement in QoL of both patients of both parents and patients, now parents themselves come asking for prophylaxis to our center.

Hopefully, all hemophilia patients will have access to CFCs in nearby hospitals and prophylaxis therapy will be given to every PWH in our country. Along with management of hemophilia, carrier testing and prenatal testing is equally important.

My message to the youth group

Celebration of the annual day of the youth group, is a moment of pride and pleasure. The hemophiliacs I have seen from the age of 0-15 are now competent as independent professionals. In the past 25 years have plodded with the PWH and have witnessed the most difficult times in their care. Hemophilia was once a matter of great concern in the 1990's when the treatment with basic products was not available, with better access to the AHF hemophilia it became better. With advanced products like long acting factor, prophylaxis and free availability of factor the status of hemophiliacs seems to have bettered.

There are a lot of challenges that have yet to be dealt with, especially for the one who have developed inhibitors, synovitis, deformities in the target joints. Prevention of recurrent bleeds through prophylaxis, education on appropriate exercise programs and nutritional care form the crux of hemophilia care today. Corrective surgeries are a need of the day for the PWH with deformities. Regular exercise programs will indeed add to the outcomes of prophylaxis and on demand therapies. Being an inherited disorder, problems in different forms are always anticipated. It is thus important to have more well equipped comprehensive care centers with dedicated professionals having the expertise in hemophilia. Persistent availability of AHF is a prime need.

We, together should join hands and attribute our efforts to make available state of art comprehensive care centers, abundant factor to most of the parts in India. Hope to see the future of hemophiliacs as having no disability and no pain.

Did you know?

"Hemophilia, in one third of the cases, arises from spontaneous mutations. It means, any of the so called healthy couples could get a Hemophiliac son at any point of time."

Total 76 Carrier Detections done in Hemophilia A and B families by DNA analysis:

In the current year 76 females (66 Hemophilia A and 10 Hemophilia B females were referred for the detection of carrier status. The analysis was performed by RFLP analysis using the polymorphic markers. 39 females were found to be carriers whereas 37 females were non carriers.

Total 67 Prenatal Diagnosis done by chorionic villus sampling procedure:

54 females belonging to Hemophilia A, 6 females belonging to Hemophilia B and 3 vWD families were referred in first trimester for prenatal diagnosis. 12 fetuses were found to be affected. HIV/HCV tests also done in ICMR.

Women Group Meetings:

Apart from the festival activities, awareness activities and Society related activities, there were 3 meetings during the year wherein we discussed in detail about the personal, school related issues, child behavior issues and solutions thereon.





We arranged a special meeting for VWD and female sufferers wherein they discussed about their problems and how they are getting treated for prolonged bleeds, hemoglobin levels etc. Few members from the Women Group participated in Standard Chartered Marathon. We celebrated Haldi Kumkum, Diwali, Christmas etc which was real enjoyment with games, music and lots of fun.

The beneficiaries of economic rehabilitation expressed their gratitude and are doing well. Knowledge sharing on Hemophilia was done by Mrs. Indira Nair through presentation on What is Hemophilia, Treatment, Chapters Functioning, HFI activities, various projects information of HFI and Save One Life, WFH information etc. This was an interactive session with lots of queries from the members which was appreciated by all.

Homeopathy Camp at HSMC:

Homeopathy Camp is being arranged every month on the 3rd Sunday wherein 20 to 25 PWH take benefit of the same. For the Homeopathy treatment, PwH only has to pay only for doctor consultation fees and the Society pays for their medicine.

AGM of HSMC Last Year:

HSMC Conduced 24th Annual General Meeting on 24th September 2016 at Jeevraj Mehta Auditorium, KEM Hospital. Total 124 members with their families attended the meeting. Where HSMC executive committee has produced minutes of last meeting, activity report, financials etc.

International Women Day celebration




Annual General Women Meet of WGHFI at Delhi on 3rd and 4th June 2017

Project under Foreign Donation (FCRA)

The Society has started the Nurses Project in October, 2011 with the fund support received from Velentine Trust of United Kingdom and donation received from Dr. Alison of U.K. from time to time. The initiative to start this project was taken by Dr. Alison, Ms. Indira Nair and Mr. ZulkefColombowala. The project was run under the guidance and supervision of Dr. DevilaSahu and KEM Occupational Therapist Dr. Jayshree Kale and Dr. KirtiPatil.

The Project ran for about 6 years from October, 2011 to July, 2017. Under this project on an average 20 therapist doctors have supported for 1874 home visits during this period. The total fund spend on this project was about Rs. 5.32 lacs. The society will revive this project on receipt of further funds.
